

Official Black Friday 2024 Contest Rules

1. General Description

Fear Free, LLC ("Fear Free") is sponsoring a contest in which eligible participants can spin the Wheelio prize wheel to receive a discount code, complete their membership purchase, and automatically be entered for a chance to win one (1) of the prizes listed below (the "Contest"). No purchase is necessary to enter or win the Contest.

By participating in the Contest, each entrant ("Entrant") agrees to comply with and be bound by these Official Rules and acknowledges that the decisions of Fear Free regarding all aspects of the Contest are final and binding. Odds of winning depend on the total number of eligible entries received during the Contest period.

2. Contest Period

The Contest begins at 12:01 AM EST on November 29, 2024, and ends at 1:59 AM EST on November 30, 2024 (the "Contest Period"). All purchases or entries must be completed within this time frame to be eligible.

3. How to Enter

To participate in the Contest, Entrants must complete the following steps:

For Renewing or Expired Members:

- Visit <u>fearfree.com</u>, click "Login," and enter your credentials.
- Navigate to your Member Homepage. (If you don't land on this page, hover over the person icon in the top right corner and click "Member Homepage.")
- Click the "Renew" button.
- Enter your unique discount code from the Wheelio spin and click "Apply Coupon."
- Complete the checkout process.

For New Members:

- Visit <u>fearfree.com</u>.
- Click "Get Started."
- Continue through the membership selection process until you reach the cart page.
- Enter the discount code from your Wheelio spin and click "Apply Coupon."
- Complete the checkout process.

Once a membership purchase has been completed, the Entrant is automatically entered into the Contest.

No Purchase Necessary Entry Option:

Entrants who do not wish to make a purchase may submit a written entry by emailing their full name, mailing address, and phone number to wags@fearfree.com during the Contest Period. The subject line of the email should read: "Fear Free Contest Entry." Limit one (1) entry per person.

4. Eligibility

The Contest is open to legal residents of countries where Fear Free operates, who have reached the age of majority in their jurisdiction at the time of entry. The Contest is void in Quebec and where prohibited by law. Employees, contractors, and agents of Fear Free and their immediate family members are not eligible to enter.

By entering the Contest, Entrants grant Fear Free the irrevocable right to use their names, images, likenesses, photographs, voices, and biographical information for advertising, publicity, and promotional purposes in any media, worldwide, without further compensation, unless prohibited by law.
